Happy New Year. Since the last issue of Bargaining Beats, we have remained extremely busy as it relates to our Central Table bargaining. I can let you know that we do in fact have confirmed bargaining dates for January 11 and 12, 2016. In the last issue I described how further delays would not be tolerated and that a change in the position of the employer needs to happen. It is my expectation that we will see such a shift. While we have not bargained at the table since December 10, we have continued to pressure government to come to a fair and reasonable deal with our membership. I am finally beginning to get the impression that our strike mandate has caught the attention of this government. In many of the conversations I have had, the January 31 deadline comes up very often. Of course, what this means at the table remains to be seen.

You likely have seen a number of other groups reach tentative agreements over the last number of weeks and you may have even heard some of the details of those settlements. Please be assured that our needs at the table are unique and that we know what it will take for MAHCP to put an agreement to our members for ratification.

I have been receiving a huge amount of questions regarding bargaining, and essential services requirements during a strike. There will be detailed information coming very soon regarding how a strike will look and what is required of members during that time. Please

# Information pickets and you

An effective way to educate the public if MAHCP is forced into a strike situation is to hold information pickets in the days leading up to the strike deadline.

Public support can help pressure governments to return to the bargaining table with solid proposals, which is our goal right now.

Information pickets are not the same as a strike. However, members do carry signs and distribute leaflets that highlight that what we're looking for is a fair deal.

What you need to know...

Members must be on their own time when participating in an information picket: either on an unpaid lunch break, off duty, on approved vacation or on a leave.

Picketers must respect property rights and not trespass, block traffic or create a public disruption. They should not prevent people from entering and exiting from the facility.

Be mindful of the language being used; threats do not lead to support. The Strike Readiness Committee will have speakers there to engage with members of the public who are asking questions or making comments.
