In order to be considered, members must submit this form and:

- □ A current professional resume.
- □ The intended course/certificate/program description including length of time and qualification earned.
- □ Acceptance letter and tuition invoice or program costs (if current program costs are unavailable, provide previous year).
- □ Proof of employment status (or of hours worked for casual/temporary employees).
- □ Personal statement that is approximately one page in length and should:
  - Outline your motivation for seeking entrance to the program/certificate.
  - Address the strengths you could bring to this program.
  - Explain how the course will enhance your current profession or progress your career, including what designation you hope to obtain, if applicable.
- □ Where a leave of absence is required to participate in the course/training opportunity, applicants must provide confirmation of leave approval from the employer, including the start and end dates of the leave of absence prior to scholarship being issued.

### Criteria

Applicants staying in the bargaining unit will be given preference. Full MAHCP membership status is defined in the MAHCP Constitution.

- » Courses/programs must be administered by an employment and social development Canada (ESDC) approved educational institution (<u>https://www.canada.ca/en/employment-social-development/programs/designated-schools.html</u>).
- » Applicants must be MAHCP members in good standing and are:
  - Permanent full-time and part-time employees who have completed the probationary period for their current position or;
  - Temporary and casual employees who have completed 1950 hours of work.
- » Where a leave of absence is required to participate in the course/training opportunity, applicants must provide confirmation of leave approval from the employer, including the start and end dates of the leave of absence.
- » Applicants can only be awarded one (1) scholarship every two (2) years.
