- Number of positions filled
- Utilization rate
- Number of ambulance ' redirects ' from hospitals (including redirects of rural

ambulances transporting to City of Winnipeg facilities)

- Number of emergency department closures
- Amount of time ambulances spend geo-posting to areas outside of their geographical base locations
- Number of times ambulances were dispatched while geo-posted
- Number of interfacility transports
- Number of hours ambulance crews were engaged in interfacility transports."

I am pleased to inform you that your request for access to these records has been granted in part.
