Criteria

Applicants staying in the bargaining unit will be given preference. MAHCP membership in good standing is defined in the MAHCP Constitution.

- » Courses/programs must be administered by an employment and social development Canada (ESDC) approved educational institution. (https://www.canada.ca/en/employment-social- development/programs/designated-schools.html).
- » Applicants must be MAHCP members in good standing and are:
 - Permanent full-time and part-time employees who have completed the probationary period for their current position or;
 - Temporary and casual employees who have completed 1950 hours of work.
- » Where a leave of absence is required to participate in the course/training opportunity, applicants must provide confirmation of leave approval from the employer, including the start and end dates of the leave of absence.
- » Applicants can only be awarded one (1) scholarship every two (2) years.
